RE: FY 2025 Temporary and Seasonal Hiring - Request for Exemption Process

Dear Chief Randy Moore:

The signed organizations write to express concerns with the budget crisis facing the agency. We understand that federal appropriations for the Forest Service have not kept up with rising expenses, including cost of living increases. We also acknowledge that if the Interior, Environment, and Related Agencies Appropriations Act (H.R.8998), passed by the House of Representatives, became law it would further cut Forest Service funding. In this uncertain fiscal environment, the agency must make hard choices to ensure that it can fulfill its commitments and pay permanent employees. Forest Service employees across the country are working to preserve public services while navigating the current budget crisis. Our organizations ask that your office assist local units in adjusting to this evolving situation by creating an exemption process that allows Regional Foresters the authority to issue exceptions to the current hiring restrictions in specific situations.

On the call you hosted on September 16, 2024, you shared that exemptions to the direction not to hire (1039) temporary employees outside of fire will be made by your office¹. Our organizations ask that you review this policy. There are many temporary positions that are funded entirely by outside grants and other nonappropriated dollars. In Region 6, one example is the Nonhighway and Off-road Vehicle Activities (NOVA) program. In Washington, NOVA currently provides more than \$1.5 million in funding

to the Forest Service for developed and dispersed recreation programs and personnel, as well as education and enforcement. These grant-restricted project dollars come from Washington state taxes and greatly enhance recreation in Region 6. Under the current hiring direction, local units may not be able to use these types of grants because units won't have needed staff. If this happened, the agency would miss out on funding and future costs would increase as the agency would add to its maintenance backlog. This unintended negative outcome can be prevented. We ask that you delegate the authority to Regional Foresters to issue an exemption to the prohibition on hiring 1039 employees, "If a unit has a grant or agreement which requires the hiring of temporary employees and those employees would be fully and only paid through an external funding source." The language in italics has been shared in the Southwestern Region by Regional Forester Michiko Martin, but for consistency it ought to be the national policy. Furthermore, the Regional Offices should handle exemptions to move the decision one level closer to on-the-ground opportunities and impacts.

Additionally, our organizations note that the Forest Service has invested significant resources in training key 1039 employees, including trail workers who have mastered traditional skills (for example blasting, crosscut falling and mule packing). Regional Foresters are well positioned to issue a limited number of exemptions focused on retaining key employees who the agency has invested large amounts of staff time to train over numerous years of seasonal work. We ask that your office allow Regional Foresters to review requests to rehire 1039 employees who preserve essential skill sets, have critical certifications, or perform roles that are vital for assuring the health and safety of the public and agency staff. Retaining these critical personnel will reduce costs and maintain agency expertise beyond the current fiscal year.

As organizations who partner with the Forest Service and support shared stewardship goals we are bracing for the ripple effects of these hiring restrictions on our own organizations and operations. The current fiscal situation and its impacts on Forest Service personnel will reduce the agency's ability to coordinate with partner organizations. Losing temporary positions will delay critical work in forest restoration, impact resource management and negatively affect rural communities. Please consider the requested changes as an opportunity to mitigate some of these challenges, as well as supporting public access and safety.

Thank you for considering our input. We recognize the deep challenges that you and your team are facing. We hope that you will provide exemptions to the hiring direction that best allows the agency to complete its mission.
